**Short Tender Notice**

Sealed quotations along with I.P.O of Rs 20/- only ( non refundable ) or Court fee of Rs. 8.25/- in favour of the Director, ASTEC, Guwahati are invited by the undersigned from registered Firm/Contractors for the temporary construction of exhibition stall at IIT, Guwahati for National Conclave for S&T Empowering of Tribal Communities. The offer should contains detailed feature and breakup of rates in item wise. The quotation should reach to the undersigned by 2.00 PM on or before 02 .11. 2022 and would be opened on the same day at 2.30 PM. Interested bidder may offer rates on items as per column given bellow ( Rates should be quoted inclusive of all applicable taxes, duty & transportation etc.)

**Specification of job:** Temporary construction of octanorm fitting exhibition stall , Chaupal (open stage),VIP Lounge, and registration counter for National Conclave for S&T Empowering of Tribal Communities at IIT, Guwahati for two days only.

**Item No 1.** Temporary construction of exhibition stall with ethnic ambience, VIP Lounge, and registration counter bamboo structure, wooden platform with carpeting, back and two side plywood wall, cloth ceiling,front side facia and water proof slanting roof. Estimated 60 Nos of Stall size (10' x 10'),one nos of VIP Lounge size 30' x 20' one nos and Registration counter size 30'x10'. (Estimated area is 7900 sq. ft) Rate per sq. ft is to be quoted.  
NB : Total cost will be taken in to consideration

**Item No 2.** Temporary construction of Chaupal (open stage with ethnic ambience) with setting and fixing with wooden framing; carpeting with wooden platform. decoration with table and VIP chair, flower decoration Size 32'x 20' (Estimated area is 640 sq ft.) Rate per sq. ft is to be quoted.  
NB : Total cost will be taken in to consideration

**Item No 3** Temporary construction of dinning hall and Kitchen shed with bamboo framing, water proof slanting roof, side walls with cloths. Size of dinning hall 80' x 60' and Size of Kitchen shad 40' x 20'nd of (Estimated area is 5600 sq ft.) Rate per sq. ft is to be quoted.
