Registered Contractor/ Firms till 2.00 pm on 09.08.2024 and the tender will be opened on the same day at 3.30 pm in presence of contractors or their authorized representatives. If the day happens to be a holiday the next working day will be treated as tender opening day.

Tender will be two bid systems i.e. technical bid and financial bid. The below mentioned documents are to be submitted with the technical bid:-

TERMS AND CONDITIONS

- It may be noted that one who has already duly qualified in technical bid in our earlier tender, they
 need not to submit their bid document again in this tender.
- 2. PAN number along with GST number should be mentioned clearly, otherwise Quotation/ tender will be rejected.
- 3. The bidder must submit their 2nd class or above Govt. Registered contractor certificate.
- 4. The bidder must proceed with the original documents to cross-verify their relevant supporting documents submitted along with their technical bid.
- 5. Rate should be quoted inclusive of all applicable taxes and applicable taxes will be deducted at source against which necessary tax deduction certificates will be issued as and when recurred.
- 6. The construction works is to be done to the full satisfaction of the officer In-charge & Engineer In-charge.
- 7. All tools and plants are to be supplied by the contractor himself.
- 8. Construction materials mentioned in the specification of items of ISI approved will have to be supplied/installed by the contractor at site conformity to the specification and satisfaction to the Engineer In-charge. Sub standard materials will not be allowed use any circumstances.
- Curing of construction of materials be done properly and water required shall have to be arranged by the contractor.
- 10. No extra payment for carrying of materials will be allowed from the council.
- 11. All work must be completed within 45 days from the date of issue of work order.
- 12. Security deposit of Rs 10% which includes 2% Earnest money will be released after 6(six) month from the date of completion of the entire work.
- The contractor will be allowed to make temporary shed at the worksite for storing their own risk.
- Estimate for the work is prepared partly as per Schedule of Rate of CPWD and partly as per current market price.
