NOTICE INVITING QUOTATIONS

Sealed quotations along with non-refundable I.P.O. of Rs.20/- or court fee of Rs.8.25/- or DD of Rs.20/- in favour of "Director, ASTEC" payable at Guwahati are invited in two-bid systems (Technical Bid & Financial Bid) by the undersigned from registered firms/manufacturer/dealers/sub dealers for purchase of 219 numbers of LCD/DLP Projectors and Screen with tripod stand and 219 numbers of Portable sound systems with 2 (two) numbers of wireless & cordless microphone for each system. The bidders should have sufficient experience & financially sound.

The quotation should be uploaded through e-procurement portal i.e. <https://assamtenders.gov.in> on or before 2.00 pm of 15th October, 2020 and same will be opened at 3.00 pm on 15th October, 2020. The rate of all the articles should be quoted inclusive of all applicable taxes & duties including transportation etc.

Director, ASTEC reserves the right to accept any offer that would be advantageous to the office and not binding to accept the lowest rate or reject all offers without assigning any reason thereof.

The bidder must submit their quotations in two bids systems, i.e. Technical Bid and Financial bid. All relevant documents, including evidences should be inserted into Technical Bid. Financial Bid will be opened for those who would duly qualify in the Technical Bid.

Rates to be mentioned separately against each item and rates to be inserted into Financial Bid only.

Rates should be quoted inclusive of all applicable taxes; transportation, all applicable duties etc and the same will be deducted at source for which necessary Tax Deduction Certificate will be issued to the supplier as and when asked for. - c) The rates should be quoted inclusive of all applicable taxes and duties including transportation etc and applicable taxes will be deducted at source against which necessary tax deduction certificate will be issued as and when required.
- d) Quality and brand of the product will be taken into consideration. Moreover, short supply of quantity and supply of inferior quality will be summarily be rejected and work order will be cancelled and security deposit amount will be forfeited without any notice thereof.

- i) Quoted rates should be valid for six months only, under no circumstances escalation of price will be entertained.

 - ii. Evidence of Registered firm/manufacturer/dealer/sub dealer etc.
 - iii. PAN No. plus GST No.
 - iv. Bidders are requested to enclose Demand Draft of Rs. 2,000/- as "cost of the tender" against the above works and DD to be prepared in favor of Director, ASTE Council payable at Guwahati which is not refundable.
 - v. Detailed specifications of the products along with Model No. / Brand name etc.
 - vi. At least three evidences of similar work done in last two years are to be furnished (i.e. work orders are to be attached)
 - vii. **Financial soundness certificate** in case of Sl.No-1 & 2, bidders are requested to enclose atleast Rs.50.00 lakhs and above to be enclosed from any nationalized/ scheduled commercial bank OR Income Tax Returns of last 3 years (financial soundness of the bidder is highly essential and hence, this point will highly be taken into consideration towards selection of Technical Bid documents).

In case of Sl.No-1 only: bidders are requested to enclose atleast **Rs.30.00 lakhs** and above to be enclosed from any nationalized/ scheduled commercial bank OR Income Tax Returns of last 3 years (financial soundness of the bidder is

highly essential and hence, this point will highly be taken into consideration towards selection of Technical Bid documents).

In case of SI.No-2 only: bidders are requested to enclose atleast **Rs.20.00 lakhs** and above to be enclosed from any nationalized/ scheduled commercial bank OR Income Tax Returns of last 3 years (financial soundness of the bidder is highly essential and hence, this point will highly be taken into consideration towards selection of Technical Bid documents).

viii. Security Deposit: in case of item **SI.No -1 &2**, Selected bidder will have to furnish a sum of Rs. 2.68 lakhs (i.e., for SI.No-1 Rs. 1.76 lakhs & in case of item SI.No-2, Rs.92, 000/-) by way of Demand draft in favor of Director, ASTE Council, payable at Guwahati as **security deposit** which will be refunded after successful completion of 6(six) months from the date of the supply.

In case of item **SI.No -1 only**, Selected bidder will have to furnish a sum of Rs. 1.76 lakh by way of Demand draft in favor of Director, ASTE Council, payable at Guwahati as **security deposit** which will be refunded after successful completion of 6(six) months from the date of the supply.

In case of item **SI.No -2 only**, Selected bidder will have to furnish a sum of Rs. Rs.92, 000/- by way of Demand draft in favor of Director, ASTE Council, payable at Guwahati as **security deposit** which will be refunded after successful completion of 6(six) months from the date of the supply.
