However, works will be assigned to the DNAs in future, based on availability of fund against EEP and other Environment Education programmes of this Council, on case-to-case basis.
- 8. The applying NGO/Societies must have an annual financial turnover of at least Rs. 3,00,000.00 (Three lakh). Audited account report to be submitted as proof of financial position.
- 9. EoI received from Aryabhatta Science Centres under ASTEC will be considered subject to recommendation of the Director, ASTE Council.
- 10. All documents of the organizations/ Societies/ Centres will be scrutinized by a Screening Committee and one District Nodal Agency shall be selected against Bajali, Biswanath, Hojai and Tamulpur districts initially for a period of 2 year.

BRIEF ABOUT ENVIRONMENT EDUCATION PROGRAMME (EEP) A PROGRAMME OF THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE, GOVT. OF INDIA

The Environment Education Programme (EEP) is an initiative of the Ministry of Environment Forest & Climate Change, Government of India for strengthening non formal environment education activities across the country. It is a component of the Central Sector scheme 'Environment Education, Awareness, Research and Skill Development (EEARSD)' that intends to leverage on the key sectoral strength of Eco-clubs already formed in schools and colleges under National Green Corps programme, in addition to targeting Youth Clubs and other such clubs/ units/ groups formed under various programmes/ schemes of the Government.

OBJECTIVES:

To sensitize children/ youth on issues related to environment and to motivate them to adopt sustainable lifestyle through varied pedagogical initiatives like workshops, projects, exhibitions, campaigns, competitions, nature camps, summer vacation programmes, etc.

ROLE OF STATE NODAL AGENCY (SNA):

Assam Science Technology and Environment Council (ASTEC) is the State Nodal Agency (SNA) for implementing the EEP in Assam and as the SNA the roles of the Council are:

- To plan and execute Sustainable Lifestyle Workshops/ Projects/ Exhibitions/ Campaigns/ Competitions/ Nature Camps/ Summer Vacation Programmes, etc.
